The City of Boca Raton, as Project Sponsor, requested that the Florida Department of Transportation (FDOT) District Four design and construct the City's NE 5th Avenue Sidewalk Project, through application to the Palm Beach Transportation Planning Agency and City of Boca Raton resolution 146-2017. This project is part of the Pedestrian Network contained in the City of Boca Raton's Comprehensive Plan. FDOT is pleased to assist the City in delivering their vision and provides the following information on this sidewalk improvements project.

Construction Cost: \$432,943.86 Construction Start: Jan. 11, 2021 Estimated Completion: Fall 2021

PROJECT IMPROVEMENTS

- Concrete sidewalk installation
- Driveway and curb & gutter replacement to align with new sidewalk installation
- Minor signage and pavement marking upgrades
- Minor landscaping relocation and irrigation repairs

TRAFFIC IMPACTS

- Lane closures are permitted 9:00 a.m. to 4:00 p.m., Monday through Friday
- Work will be done in phases to reduce impacts to motorists and pedestrians
- Sidewalk detours will be in place when needed; pedestrian access will be maintained at all times
