S.R. 811/ALTERNATE A1A RESURFACING, RESTORATION, AND REHABILITATION PROJECT

The Florida Department of Transportation (FDOT) invites the community to a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming S.R. 811/Alternate A1A Resurfacing, Restoration, and Rehabilitation Project. The project limits are on S.R. 811/Alternate A1A from RCA Boulevard to Donald Ross Road in the City of Palm Beach Gardens and the Town of Jupiter. This project aims to enhance the safety, travel efficiency, resiliency and longevity of the infrastructure for our communities. Please see below for detailed meeting information.

Construction Cost: \$5.9 Million Construction Start: October 2025 Estimated Completion: Summer 2026

PROJECT IMPROVEMENTS

- Milling and repaving the roadway throughout the project limits to enhance infrastructure resilience and safety for the community.
- Constructing a second left turn lane at RCA Boulevard to improve traffic flow and increase vehicular capacity.
- Installing patterned pavement at intersections.
- Upgrading curb ramps and replacing sections of the existing sidewalk throughout the project corridor to improve pedestrian safety and connectivity.
- Upgrading pedestrian signals with new LED countdown timers at intersections throughout the project corridor to enhance pedestrian safety and accessibility.
- Upgrading signage and pavement markings, including installing green bicycle lane markings, to enhance visibility and safety.

TRAFFIC IMPACTS

- Work will occur in phases to minimize impacts to the public.
- Lane closures are permitted as follows:
 - 9:00 a.m. until 4:00 p.m., daily
 - 8:00 p.m. until 6:00 a.m., nightly
- Sidewalk and curb ramp closures will be implemented as needed with temporary pedestrian detours.
- Access to businesses and residences will be maintained at all times.
