The Florida Department of Transportation (FDOT) is pleased to provide information regarding the S.R. 710/Beeline Highway Reconstruction Project in the cities of Palm Beach Gardens, Riviera Beach, and West Palm Beach.

Construction Cost: \$148.2 million

Construction Start: March 2024

Estimated Completion: Late 2029


PROJECT IMPROVEMENTS

- Widening of S.R. 710/Beeline Highway from Northlake Boulevard to S.R. 708/Blue Heron Boulevard from 4 lanes to 6 lanes.
- Replacing and widening the Florida's Turnpike bridge over S.R. 710/Beeline Highway.
- Constructing an at-grade partial Continuous Flow Intersection (CFI) at the intersection of S.R. 710/Beeline Highway and Northlake Boulevard.
- Adding sidewalks and bicycle lanes on both sides of S.R. 710/Beeline Highway.
- Constructing an 8-foot high privacy wall adjacent to the Steeplechase Community along S.R. 710/Beeline Highway.
- Upgrading railroad crossings, drainage, signage, lighting, signalization, and pavement markings throughout project limits.
- Intelligent Transportation System (ITS) upgrades.

TRAFFIC IMPACTS

- Lane closures on S.R. 710/Beeline Highway, Northlake Boulevard, Jog Road, and S.R. 708/Blue Heron Boulevard will take place daily and nightly as needed to safely facilitate construction.
- One lane of Florida's Turnpike may be closed nightly as needed, 10:00 p.m. until 6:00 a.m., Sunday night and 8:00 p.m. until 6:00 a.m., Monday through Thursday night.
- Florida's Turnpike ramps at S.R. 710/Beeline Highway may be closed nightly as needed, 10:00 p.m. until 6:00 a.m., Sunday night and 9:00 p.m. until 5:00 a.m., Monday through Thursday night.
- Additional information about lane closures, detours, and pedestrian impacts will be provided in the weekly traffic report distributed by FDOT and can be viewed using the following link:
