### State Road (SR) 710/Beeline Highway Reconstruction Project

The Florida Department of Transportation (FDOT) will host a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming State Road (SR) 710/Beeline Highway Reconstruction Project in the cities of Palm Beach Gardens, Riviera Beach, and West Palm Beach. **Construction Cost:** \$148.2 million

**Construction Start:** March 2024

**Estimated Completion:** Late 2029

### PROJECT IMPROVEMENTS

- Widening of SR 710/Beeline Highway from Northlake Boulevard to SR 708/Blue Heron Boulevard from 4 lanes to 6 lanes
- Replacing and widening the Florida's Turnpike bridge over SR 710/Beeline Highway
- Constructing an at-grade partial Continuous Flow Intersection (CFI) at the intersection of SR 710/Beeline Highway and Northlake Boulevard
- Adding sidewalks and bicycle lanes on both sides of SR 710/Beeline Highway
- Constructing an 8-foot high privacy wall adjacent to the Steeplechase Community along SR 710/Beeline Highway
- Upgrading railroad crossings, drainage, signage, lighting, signalization, and pavement markings throughout project limits
- Intelligent Transportation System (ITS) upgrades

### TRAFFIC IMPACTS

- Lane closures on SR 710/Beeline Highway, Northlake Boulevard, Jog Road, and SR 708/Blue Heron Boulevard will take place daily and nightly as needed to safely facilitate construction
- One lane of Florida's Turnpike may be closed nightly as needed, 10:00 p.m. until 6:00 a.m., Sunday night and 8:00 p.m. until 6:00 a.m., Monday through Thursday night
- Florida's Turnpike ramps at SR 710/Beeline Highway may be closed nightly as needed, 10:00 p.m. until 6:00 a.m., Sunday night and 9:00 p.m. until 5:00 a.m., Monday through Thursday night

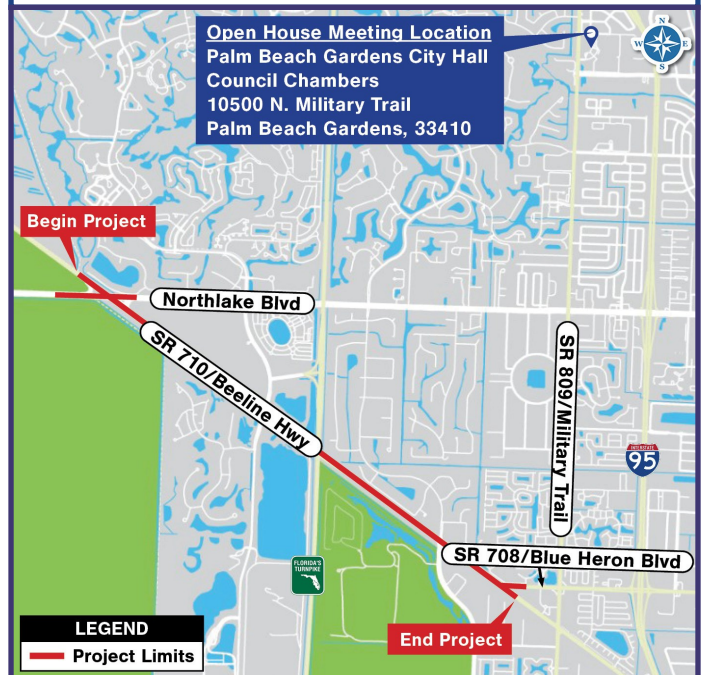
