CONSTRUCTION IMPACTS

- Work will be scheduled in phases to reduce effects of construction on the community
- Temporary lane closures will take place during non-peak hours to reduce impact to the public
- Access to businesses and private properties will be maintained at all times during construction

PROPOSED IMPROVEMENTS

NW 16 Street and NW 19 Street

From NW 49 Avenue to NW 47 Avenue

- Create pavement markings to indicate a shared lane for bicycles and automobiles (SHARROW)*
- Construct 8 foot sidewalks on both sides

From NW 47 Avenue to SR 7

Widen roadway and construct 5-foot bike lanes

NW 26 Street

From NW 49 Avenue to NW 42 Avenue

- Construct 6-foot to 8-foot sidewalks on north side
- Create pavement markings to indicate a shared lane for bicycles and automobiles (SHARROW)*

From NW 42 Avenue to SR 7

Widen roadway and construct 5-foot bike lanes



* SHARROW Marking

Additional improvements in all segments:

- Reconstruct driveways
- Modify drainage and swales
- Improve sidewalks accessibility per Americans with Disability Act (ADA) Standards.
