## SR 5/North Federal Highway Milling and Resurfacing Project

The Florida Department of Transportation (FDOT) will host an In-Person Coffee with Construction Open House regarding the upcoming improvements to SR 5/North Federal Highway from south of 10th Avenue South to 6th Avenue North in the City of Lake Worth Beach. Please see below for detailed meeting information.

**Construction Cost:** \$2.3 million    **Construction Start:** Late May/Early June 2024    **Estimated Completion:** Spring 2025

### PROJECT IMPROVEMENTS

- Milling and resurfacing the existing roadway.
- Adding drainage and constructing a raised intersection at 7<sup>th</sup> Avenue South.
- Upgrading pedestrian curb ramps to meet Americans with Disabilities Act (ADA) standards.
- Installing signalized pedestrian crossings with Rectangular Rapid Flashing Beacons (RRFB's) at 8<sup>th</sup> Avenue South, 3<sup>rd</sup> Avenue North, and 4<sup>th</sup> Avenue North.
- Removing the existing midblock crossing between 4<sup>th</sup> Avenue North and 5<sup>th</sup> Avenue North.
- Upgrading vehicular and pedestrian signalization at 6<sup>th</sup> Avenue South and 2<sup>nd</sup> Avenue North.
- Installing lighting at the intersections of 8<sup>th</sup> Avenue South, 6<sup>th</sup> Avenue South, 2<sup>nd</sup> Avenue North, 3<sup>rd</sup> Avenue North, and 4<sup>th</sup> Avenue North.
- Upgrading signage and pavement markings for shared bicycle facilities and buffered bicycle lanes.

### TRAFFIC IMPACTS

- Work will occur in four phases to minimize impacts to the public.
- Vehicular and pedestrian detours will be in place for intersection reconstruction work at 7th Avenue South and 3rd Avenue South.
- Construction work will be allowed between the following hours:
  - SR 5/North Federal Highway from 10<sup>th</sup> Avenue South to 2<sup>nd</sup> Avenue South: 8:00 a.m. to 6:00 p.m.
  - SR 5/North Federal Highway from 2<sup>nd</sup> Avenue South to 2<sup>nd</sup> Avenue North: 10:00 p.m. to 8:00 a.m.
  - SR 5/North Federal Highway from 2<sup>nd</sup> Avenue North to 6<sup>th</sup> Avenue North: 8:00 a.m. to 6:00 p.m.
- Pedestrian detours will be in place during sidewalk construction as needed.

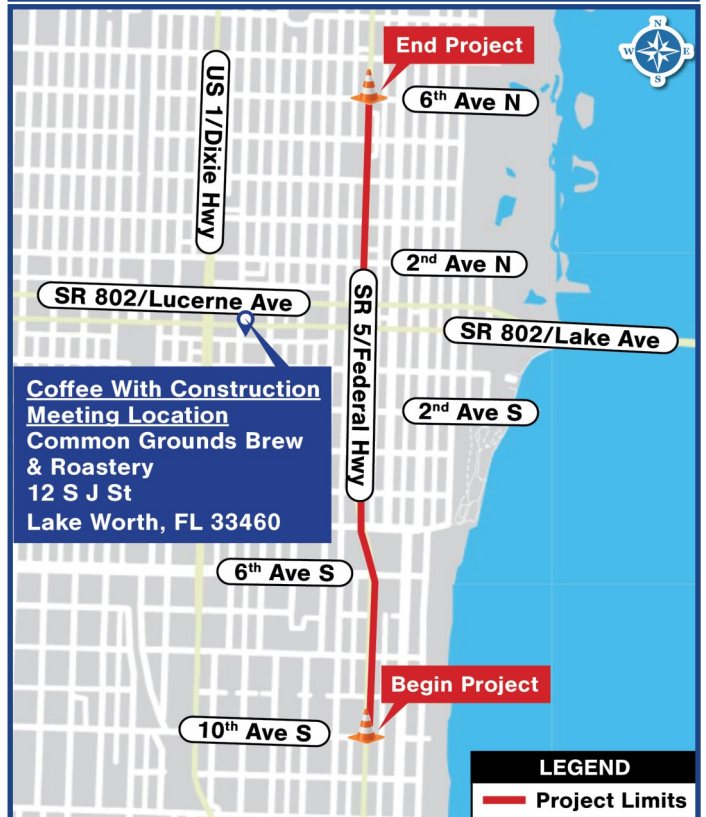
