## State Road 700/Conners Highway Resurfacing, Restoration, and Rehabilitation Project

The Florida Department of Transportation (FDOT) will host a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming SR 700/Conners Highway Resurfacing, Restoration, and Rehabilitation Project in Palm Beach County. Please see below for detailed meeting information.

Construction Cost: \$17.8 million Construction Start: April 2024 Estimated Completion: Early 2026

#### **PROJECT IMPROVEMENTS**

- Milling and resurfacing of SR 700/Conners Highway
- Replacing and upgrading existing curb ramps to meet Americans with Disabilities Act (ADA) standards
- Installing rumble strips for the roadway segment with posted speed greater than 50 miles per hour (mph)
- Minor shoulder widening in various locations
- Installing, upgrading and repairing guardrail as needed
- Upgrading pedestrian signals, pavement markings and signs

#### TRAFFIC IMPACTS

- Work will occur in phases to minimize impacts to the public
- SR 700/Conners Highway will be closed in segments.
  Detours will be used throughout construction and will be
  closely coordinated with the community and agricultural
  industry. Advanced notice will be provided and detours
  will be clearly marked.


