The Florida Department of Transportation (FDOT), District Four, will conduct a public meeting regarding the proposed improvements along SR A1A from south of CR 782/East Linton Boulevard to north of SR 806/East Atlantic Avenue, in Palm Beach County. PROPOSED IMPROVEMENTS

- Repaving and restriping the existing roadway
- Improving safety
- Upgrading pedestrian signals and midblock crossings
- Upgrading lighting at signalized intersections
- Installing new sidewalk on the east side between White Drive and north of Bucida Road

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the inconvenience to the community
- Lane closures, temporary sidewalk closures, and detours will occur during non-peak hours to minimize impacts on traffic
- Access to businesses and residential properties will be maintained at all times during construction

CONSTRUCTION INFORMATION

- Construction Start Date: Summer 2024
- Anticipated Completion: Summer 2025
- Construction Cost Estimate: \$1.2 Million
