PROJECT IMPROVEMENTS

Scope of work includes:

- Widening eastbound SR 704/Okeechobee Boulevard to provide an exclusive turn lane to the I-95 southbound entrance ramp

TRAFFIC IMPACT

- Lane closures on Okeechobee Boulevard are permitted nightly, 9:00 p.m. until 5:00 a.m., Sunday through Thursday.
- Full ramp closures will be required for paving operations and are permitted nightly, 11:00 p.m. until 6:00 a.m., Sunday through Thursday; advanced notice and detour information will be provided prior to any closures.
- To ensure pedestrian safety, the south sidewalk of Okeechobee Boulevard, from just west of I-95 to Parker Avenue, will be closed and detoured to the north sidewalk for the duration of this project.
