The City of Delray Beach, as Project Sponsor, requested that the Florida Department of Transportation (FDOT), District Four design and construct the George Bush Boulevard Improvements Project, through City of Delray Beach Resolution 06-18. FDOT is pleased to assist the City with completing these improvements, and will host a Virtual Public Meeting and an In-person Construction Open House on Thursday, July 8, 2021. The Virtual Public Meeting will take place from 5:00 p.m. to 6:00 p.m., with the In-person Construction Open House to follow from 6:00 p.m. to 7:00 p.m. Please see below for detailed meeting information.

Construction Cost: \$2,029,421 Construction Start: July 16, 2021

PROJECT IMPROVEMENTS

- Milling and resurfacing the roadway with minor widening
- Concrete sidewalk and driveway replacement, including curb and gutter improvements
- Signing and pavement marking upgrades, including bike lane and detectable warning surfaces
- Drainage and utility improvements

TRAFFIC IMPACTS

- In compliance with the City of Delray Beach Noise Ordinance, work will take place during daytime hours:
 Monday through Friday, 7:00 a.m. to 6:00 p.m.
 Saturday, 8:00 a.m. to 4:00 p.m.
- Lane closures are permitted during working hours; however, lane closures at St. Vincent Ferrer Catholic School will be coordinated around the 'School Speed Zone' drop-off/pick-up times to minimize traffic impacts
- Full roadway closures will be required to install new drainage upgrades; advanced notice will be provided with motorist and pedestrian detours clearly marked
- Pedestrian, driveway and street access will be maintained at all times
