Purpose: To replace the existing bridge and improve bicycle and pedestrian access

Project Length: 550 feet

Project Limits: From Oregon Lane to Avocet Road

Project Duration: 482 days (plus holidays and weather days)

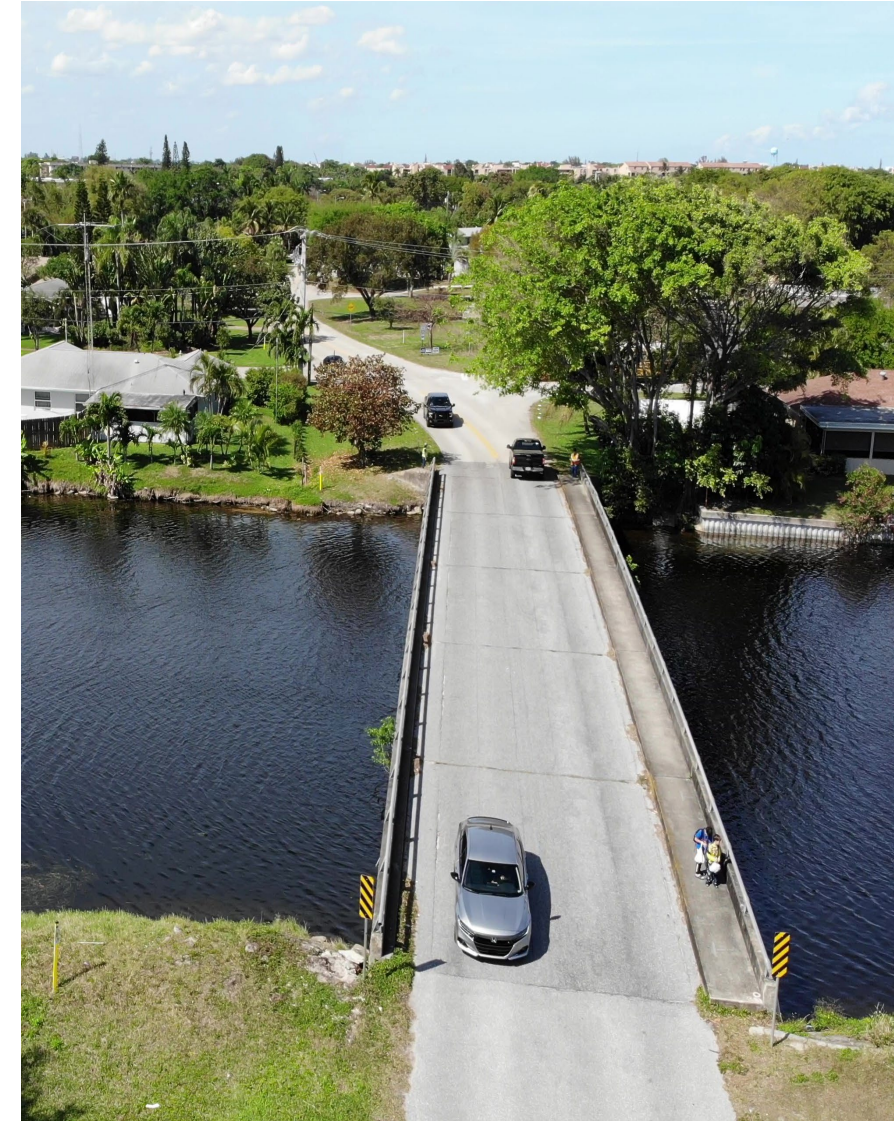
Bridge Closure: Duration of construction

Construction Begins: August 2, 2021

Anticipated Completion: Late 2022

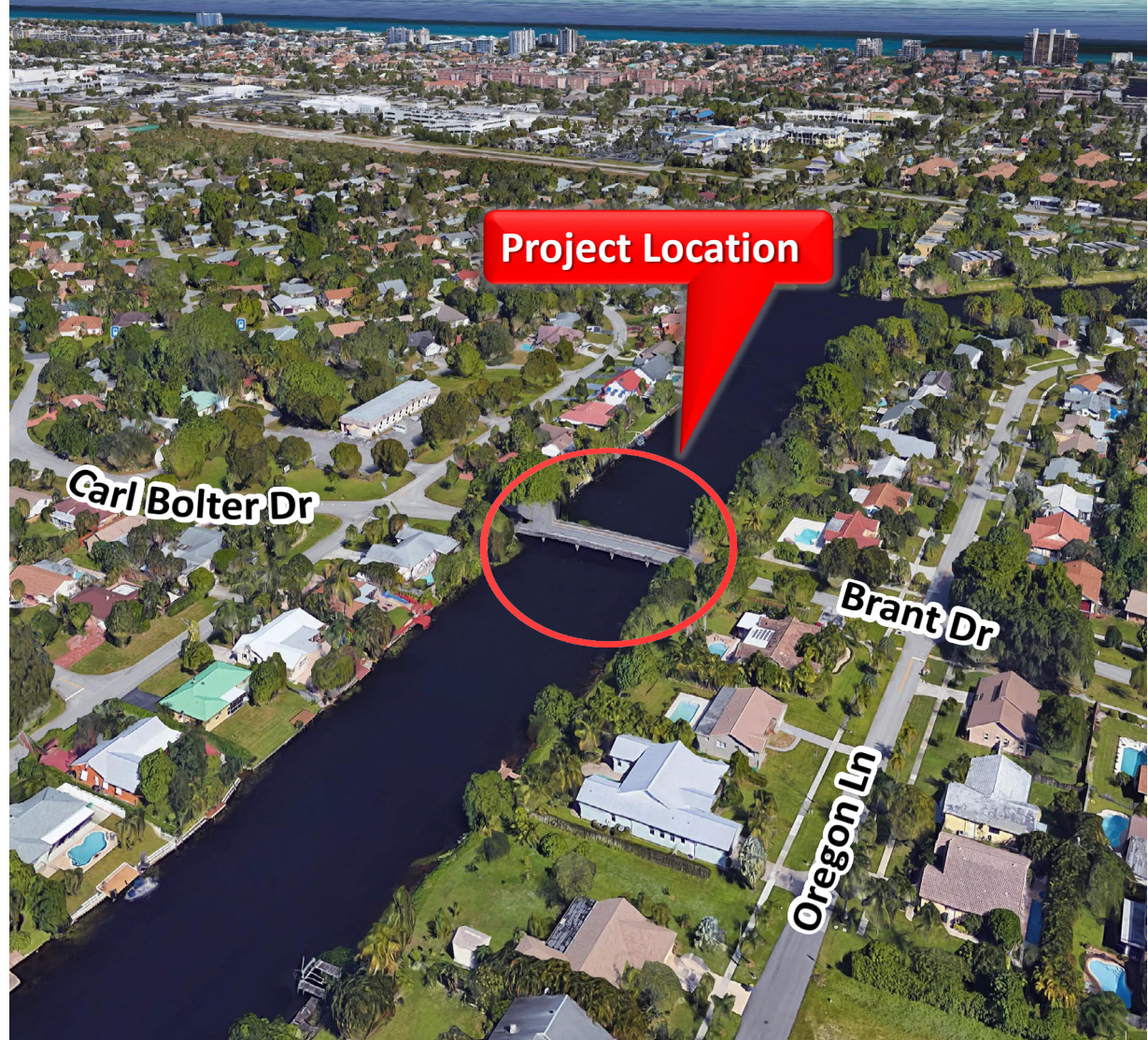

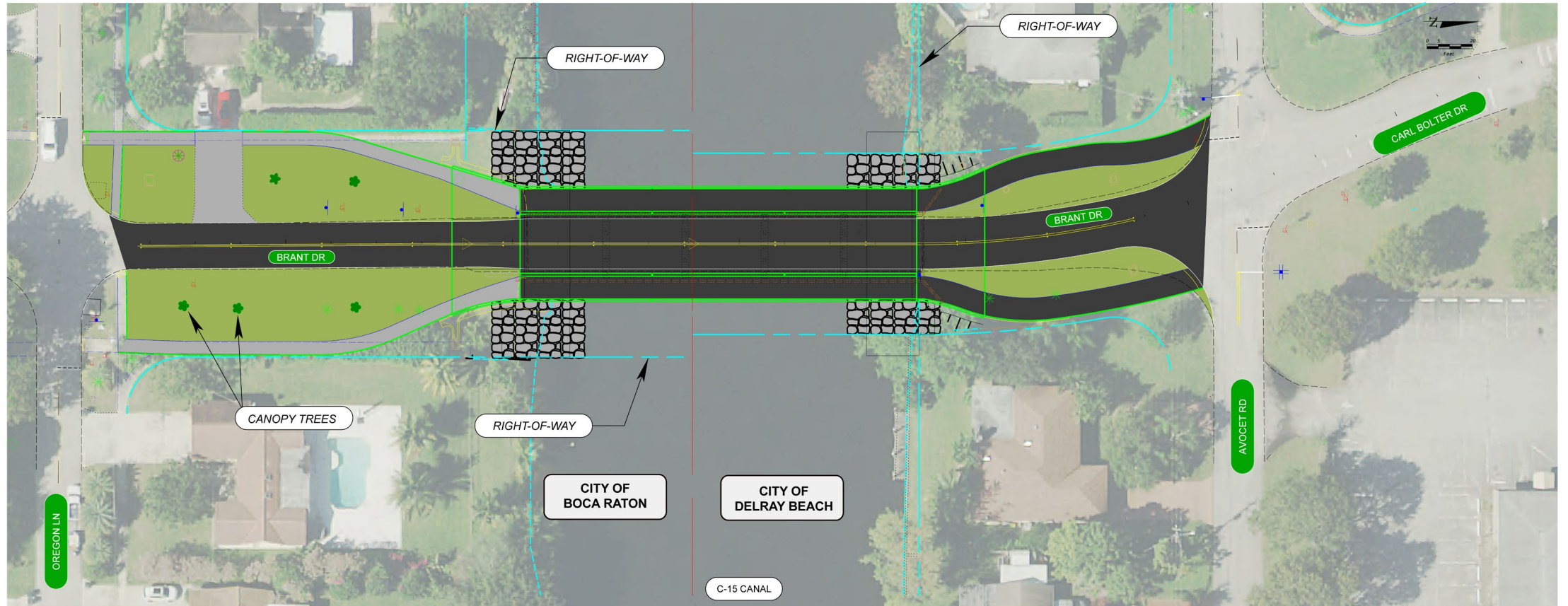


Project Improvements

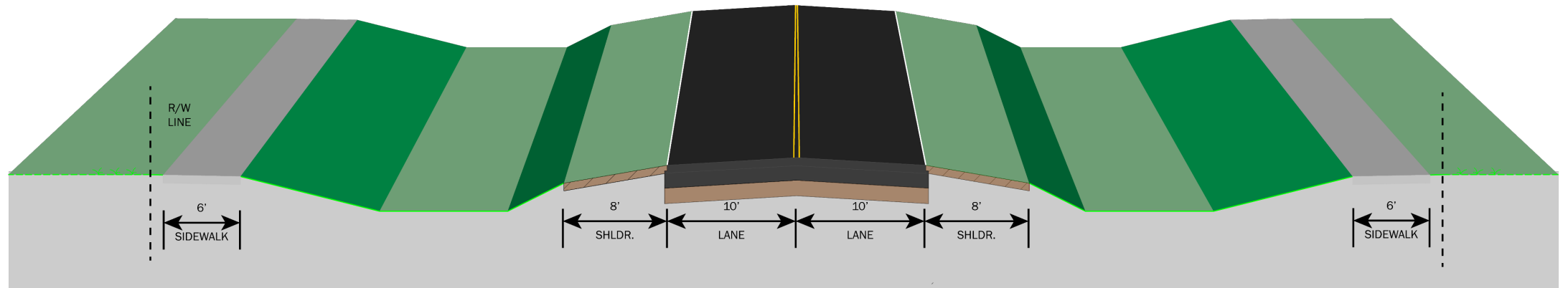
- Replacing the two-lane Brant Drive Bridge (Bridge No. 935501) over the C-15 Canal with a new bridge consisting of two travel lanes and 10-foot shared-use paths in each direction
- Constructing 10-foot shared-use paths in each direction north of the bridge
- Reconstructing sidewalks south of the bridge
- Adding decorative lighting and drainage
- Upgrading signage and pavement markings
- Reconstructing roadway approaches and milling and resurfacing

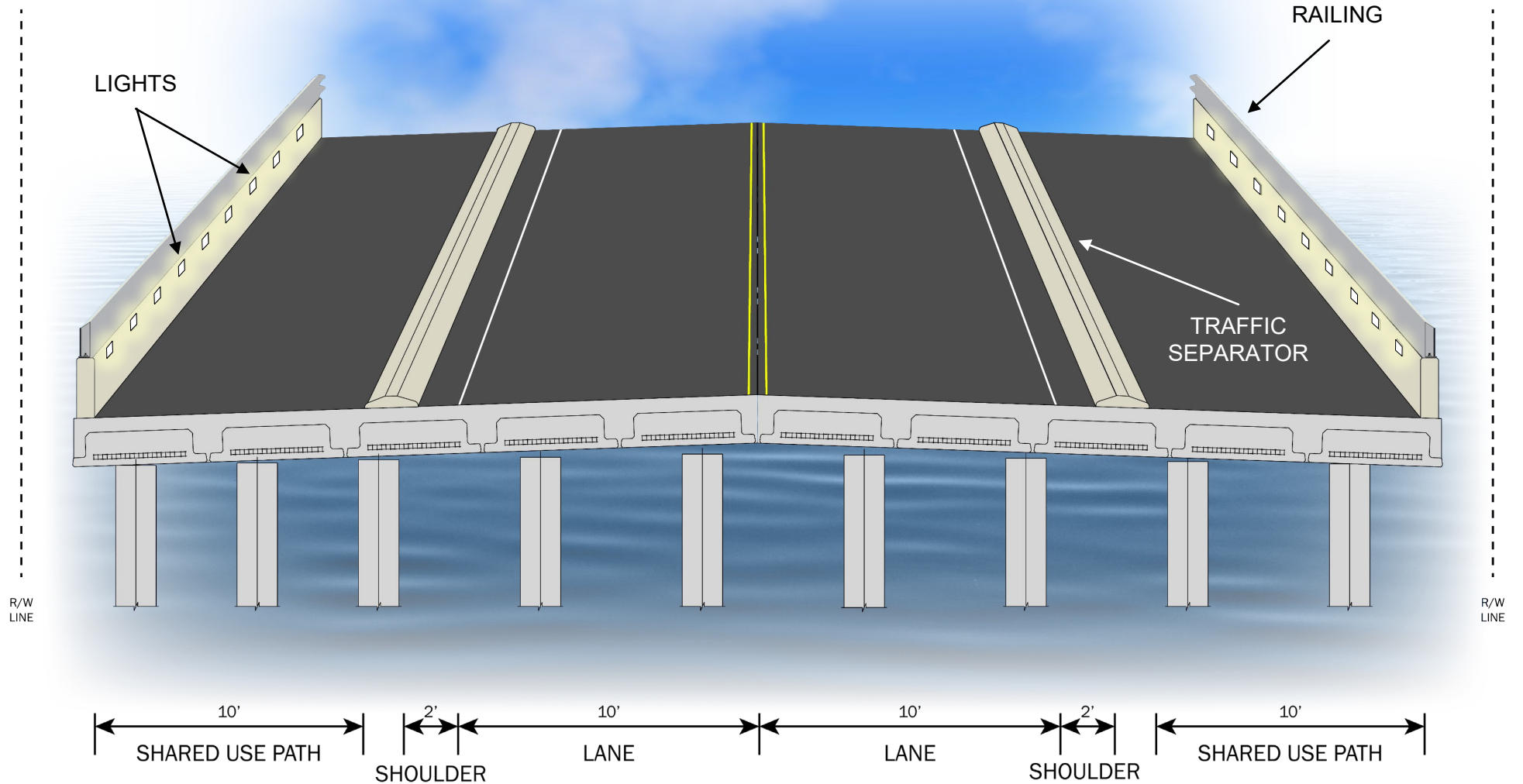

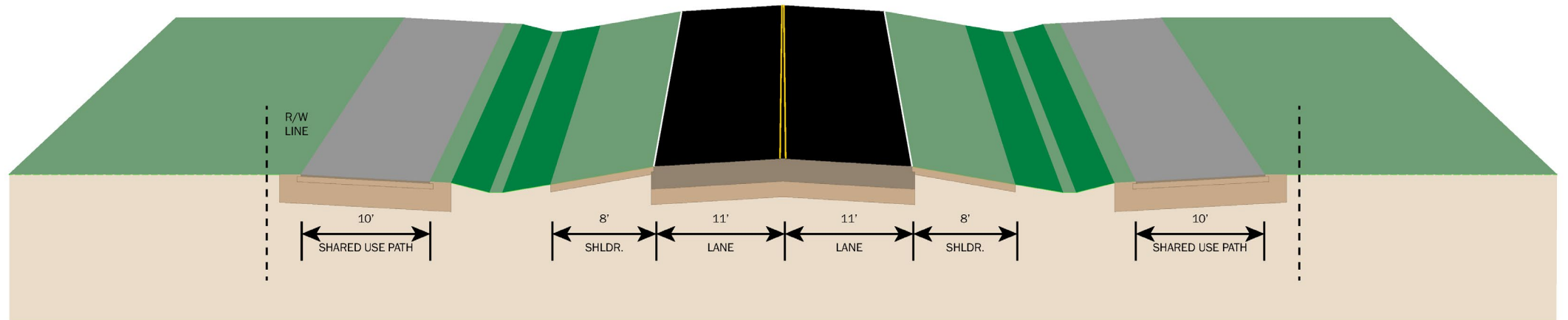


South of Bridge, City of Boca Raton

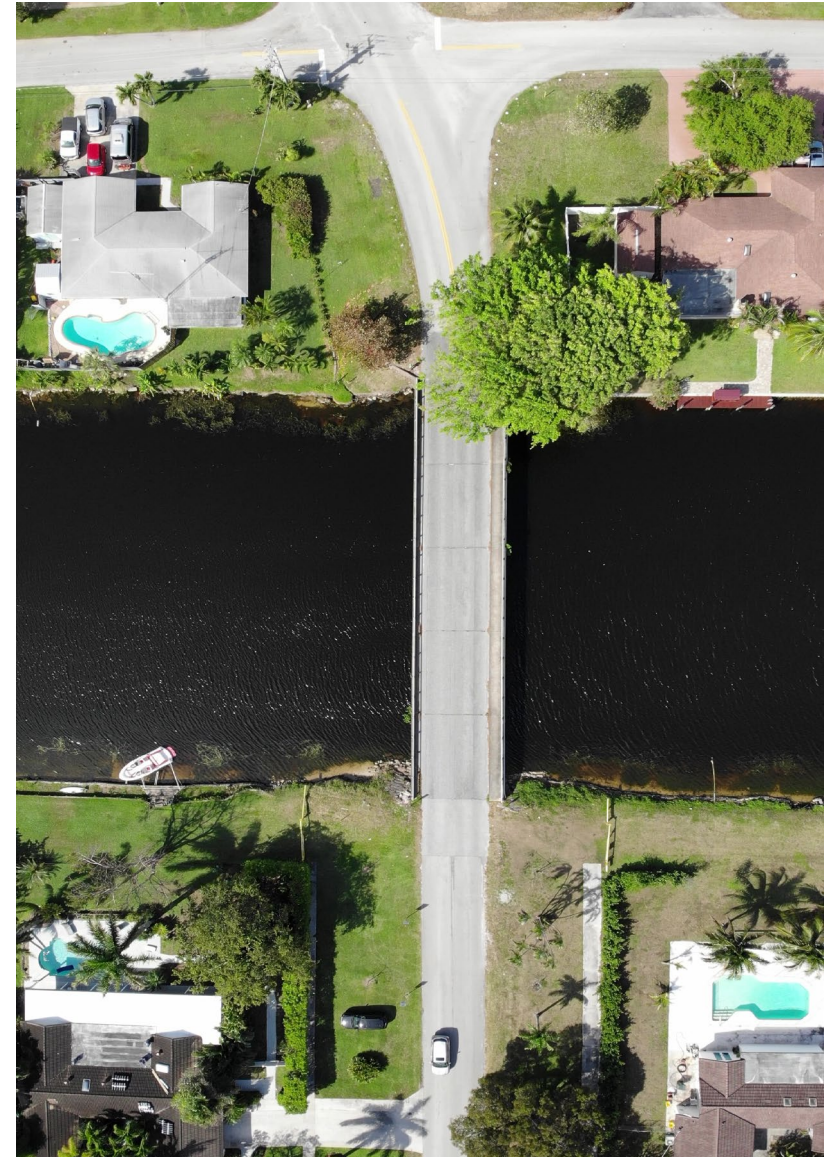
Traffic Impacts

- A full bridge closure will occur for the duration of construction.
- Vehicle and pedestrian traffic impacted.
- Traffic will be detoured to North Dixie Highway via Hidden Valley Boulevard and Lindell Boulevard.
- Access to adjacent properties will be maintained.
- Marine traffic will continue to have access through the canal.
- No conflict with existing detour for Clint Moore Road.



What to Expect

- Detour and work zone signage will be installed north and south of the bridge work zone.
- Construction hours are:
 - 7 a.m. to 6 p.m. Monday through Friday
 - 8 a.m. to 4 p.m. Saturdays (advance approval required)
- Ongoing coordination with the cities of Delray Beach and Boca Raton
- Selective tree protection and removal within the project corridor
- Pile driving activities will cause enhanced noise levels.
- Ongoing monitoring will occur on nearby structures.
- Coordination will occur with emergency responders and the Palm Beach County School District Transportation Department during the bridge closure



Community Outreach

- The Community Outreach Specialist will distribute project update flyers via email and door-to-door as needed.
- Traffic impacts will be included in the FDOT District Four Communications Manager's Weekly Traffic Impact Press Release.
- The Project Team will meet with city/county officials, community groups and property owners regarding project updates as needed.

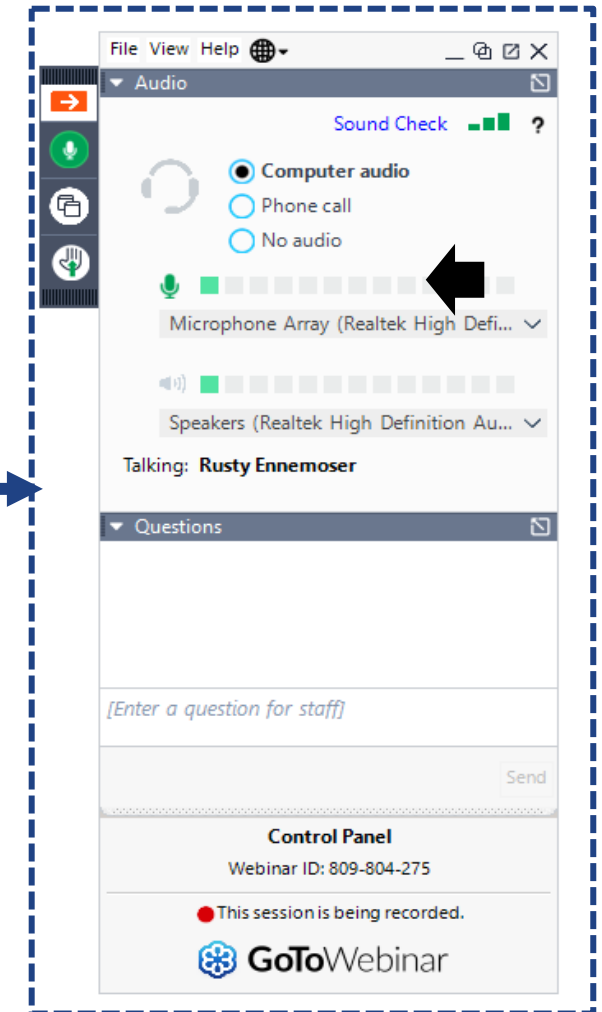

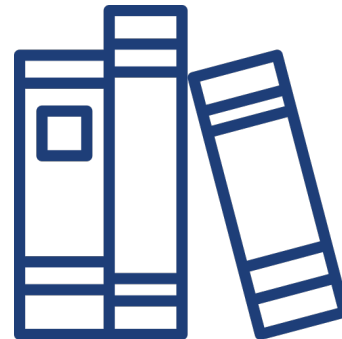

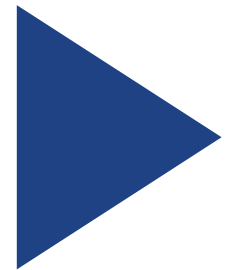
