### **ROAD CONSTRUCTION WORK ON SR 700/CONNERS HIGHWAY FROM CR 717/MUCK CITY ROAD TO TRIANGLE PARK**

- Beginning at 12:01 a.m., Monday, October 21, 2024, SR 700/Conners Highway from CR 717/Muck City Road to Triangle Park will be closed around-the-clock through approximately 5 pm. Sunday, May 18, 2025 for road construction work
- Northbound SR 700/Conners Hwy will be detoured via CR 717/Muck City Rd, S Lake Ave, and SR 15/E Main St
- Southbound SR 700/Conners Hwy will be detoured via SR 15/E Main St, S Lake Ave, CR 717/Muck City Rd and SR 700/Conners Hwy
- Emergency/First Responder access and local access will be maintained and coordinated

## AREA DETOUR UNRELATED TO THE SR 700/CONNERS **HIGHWAY PROJECT:**

- SR 729/State Market Rd from Larrimore Rd to SR 15/E Main St is closed around-the-clock through Monday, December 23, 2024 for road construction work
- Northbound SR 729/State Market Rd will be detoured via S Lake Ave and SR 15/E Main St
- Southbound SR 729/State Market Rd will be detoured via SR 15/E Main St along S Lake Ave
- Emergency/First Responder access and local access will be maintained and coordinated

#### **PROJECT IMPROVEMENTS**

- Milling and resurfacing of SR 700/Conners Highway to ensure long-term resilience
- Replacing and upgrading existing curb ramps to meet Americans with Disabilities Act (ADA) standards for pedestrian safety
- Installing rumble strips for the roadway segment with posted speed greater than 50 miles per hour (mph) to ensure motorist safety
- Minor shoulder widening in various locations to improve safety within the corridor
- Installing, upgrading and repairing guardrail as needed for motorist safety
- Upgrading pedestrian signals, pavement markings and signs to ensure pedestrian safety


