#### Australian Avenue Lighting Improvements Project

The City of Riviera Beach, as Project Sponsor, requested that the Florida Department of Transportation (FDOT), District Four, design and construct the Australian Avenue Lighting Improvements Project, through application to the Palm Beach Transportation Planning Agency and City of Riviera Beach Resolution 2020-0987. FDOT is pleased to assist with completing these improvements, and will host a Virtual Public Meeting and an In-Person Construction Open House on Tuesday, November 16, 2021. The Virtual Public Meeting will take place from 5:00 p.m. to 6:00 p.m., with the In-Person Construction Open House to follow from 6:00 p.m. to 7:00 p.m. Please see below for detailed meeting information.

Construction Cost: \$2,952,230 Construction Start: November 22, 2021 Estimated Completion: Spring 2023

#### **PROJECT IMPROVEMENTS**

- Install a continuous decorative LED lighting system
- Replace concrete sidewalk and driveway in locations impacted by LED light pole installations and curb and gutter improvements
- Upgrade pedestrian curb ramps and pavement markings to meet current American with Disabilities Act (ADA) requirements

#### **TRAFFIC IMPACTS**

- Construction will occur in phases to minimize impacts to the public
- Lane closures can be expected daily, 9:00 a.m. to 3:00 p.m., and nightly, 7:00 p.m. to 6:00 a.m., Sunday night through Friday morning
- Lane closures at West Riviera Elementary School and Lincoln Elementary School will be coordinated around 'School Speed Zone' drop-off/pick-up times to minimize traffic impacts
- Pedestrian access will be maintained at all times, including access to bus stops and side streets with pedestrian detours clearly marked
