### SR 800/Spanish River Boulevard Over the Intracoastal Waterway (ICWW) Scour Countermeasures Project

The Florida Department of Transportation (FDOT) will host a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming improvements on SR 800/Spanish River Boulevard over the ICWW Bridge #930266 & 930154 from Milepost (MP) 0.311 to 0.403 within the City of Boca Raton. Construction Cost: \$2.1 million Construction Start: January 2024 Estimated Completion: Fall 2024

#### **PROJECT IMPROVEMENTS**

 Installing Articulated Concrete Block (ACB) at the river bed to protect the bridge foundations from erosion on the eastbound and westbound SR 800/Spanish River Boulevard bridges.

#### TRAFFIC IMPACTS

- Single lane closures will only be permitted on the frontage road, daily, 7:00 a.m. until 6:00 p.m., Monday through Friday, and 8:00 a.m. until 6:00 p.m., Saturday.
- Closures will not be permitted on Sunday.
- Closures will not be permitted on Spanish River Boulevard.
- Access to properties along the frontage road will be maintained throughout construction.

#### **MARINE IMPACTS**

 Half-channel closures can be expected during construction operations. Access will be maintained at all times.


