# FDOT Palm Beach County Traffic Report

**PALM BEACH COUNTY, Fla.** – Palm Beach County traffic will be affected this week by ongoing construction projects and maintenance work, Florida Department of Transportation (FDOT) officials report. Closures will be in effect on I-95 and in other areas throughout Palm Beach County for construction activities. Please note, that any full road, ramp, or bridge closures have been highlighted below.

# **CONSTRUCTION PROJECTS**

## **INTERSTATE 95**

1. <u>I-95 from south of Glades Road to south of Linton Boulevard and SR 808/Glades</u> <u>Road from NW 22<sup>nd</sup> Way to West University Drive in the Cities of Boca Raton and</u> <u>Delray Beach (95 Express Phase 3B-2)</u>

**Description:** 95 Express Lanes Phase 3B-2 will extend the existing Express Lanes north from just south of Glades Road to just south of Linton Boulevard in Palm Beach County. One lane will be added, and the High Occupancy Vehicle (HOV) lane will be converted to create two Express Lanes in each direction. The number of General Use lanes will remain the same. Access to the Express Lanes will be provided via two designated ingress and egress locations—between Glades Road and Congress Avenue. The scope of work includes reconfiguration of the SR 808/Glades Road Interchange to a Diverging Diamond Interchange (DDI). Additional project improvements include overhead sign structure installation, Intelligent Transportation System (ITS) and Express Lane markers, new signalization, lighting, signing and pavement markings, and ramp signalization at five interchanges from Glades Road to Linton Boulevard. Shoulder-mounted sound barrier walls will be constructed along I-95 northbound between Clint Moore Road and Linton Boulevard, ground-mounted sound walls will be installed on the south side of Yamato Road east of I-95 adjacent to the University Heights Community and along I-95 northbound south of Linton Boulevard adjacent to the Tierra Verde Community. The Clint Moore Road Bridge over I-95 will be fully reconstructed and the Glades Road bridge over the South Florida Regional Transportation Authority (SFRTA) railroad tracks and Military Trail and the I-95 bridge over the C-15 Canal (between Peninsula Drive and Linton Boulevard) will be widened. Cost/Completion: \$148 million. Completion is expected in late 2023.

# I-95 Traffic Impact:

- I-95 will have up to four lanes closed in each direction nightly, 9 p.m. until 5:30

   a.m., Sunday through Thursday. The first lane will close at 9 p.m., the second lane will
   close at 9:30 p.m., and the third and fourth lane will close at 11 p.m.
- I-95 southbound from Spanish River Road to Glades Road is in a new traffic pattern with traffic shifted to the outside to allow for median construction, through March 2023.
- I-95 Northbound Full Closure Notice: All I-95 northbound lanes at SR-808/Glades Road will be closed to traffic overnight, Tuesday, March 14 through Thursday, March 16 for overhead sign structure installation. The first lane will close at 9 p.m., the second lane will close at 10 p.m., and all lanes will be closed by 11 p.m., reopening by 5 a.m. each morning. Traffic will be detoured via the northbound exit ramp to SR-808/Glades Road, US-1/Federal Highway and SR-794/Yamato Road. FHP will be onsite to assist motorists. Please see detour flyer attached.
- I-95 Northbound Full Closure Advanced Notice: All I-95 northbound lanes at SR-808/Glades Road will be closed to traffic overnight, Sunday, March 19 through Thursday, March 23 for overhead sign structure installation. The first lane will close at 9 p.m., the second lane will close at 10 p.m., and all lanes will be closed by 11 p.m., reopening by 5 a.m. each morning. Traffic will be detoured via the northbound exit ramp to SR-808/Glades Road, US-1/Federal Highway and SR-794/Yamato Road. FHP will be onsite to assist motorists. Sunday, March 26 will be used as a contingency night if needed. Please see detour flyer attached.
- Advanced Notice: All access to and from SR-808/Glades Road at I-95 will be restricted to implement final configuration of the Diverging Diamond Interchange, 11 p.m., Friday, March 24 through 5 a.m., Monday, March 27. The

# **Glades Road Impact:**

- The SR-808/Glades Road and I-95 interchange is in a new Diverging Diamond configuration. Please use caution as you approach the interchange – the posted speed is 35 MPH. The I-95 entrance ramps are accessible from the far left lane. The DDI is in a temporary configuration with 3 travel lanes available in each direction while outstanding work is ongoing. The final configuration of 4 lanes in each direction will be implemented by March 27, 2023.
- One eastbound and westbound lane of the DDI will be closed, as needed, 9:30 a.m. until 4 p.m., Monday through Friday, for curb and sidewalk construction.
- Two eastbound outside lanes of Glades Road from Renaissance Way to west of the I-95 southbound entrance ramp will be closed for drainage operations, 10 p.m., Saturday night, March 11 through 5 a.m. Monday, March 13.
- Westbound Glades Road, between St. Andrews Blvd and University Drive/FAU Blvd, will have one lane closed daily, 9:30 a.m. until 4 p.m., Monday through Friday and from 9 p.m. until 6 a.m., Sunday through Thursday.
- Eastbound Glades Road, between St. Andrews Boulevard and University Drive/FAU Blvd, will have one lane closed daily, 9:30 a.m. until 4 p.m., Monday through Friday and from 9 p.m. until 6 a.m., Sunday through Thursday.
- To ensure pedestrian safety during roadway widening and drainage activities, the south sidewalk of Glades Road from Airport Road/NW 15<sup>th</sup> Avenue to Executive Center Drive is closed through March 2023. Pedestrian traffic is being detoured to the north sidewalk during this phase of construction. Please use caution as there is a new sidewalk configuration. Use crosswalks and adhere to pedestrian signals.
- Full Closure Advanced Notice: Westbound SR-808/Glades Road at SR-9/I-95 will be closed for implementation of the final configuration of the Diverging Diamond Interchange (DDI), 11 p.m., Friday, March 24 through 5 a.m., Monday, March 27. Traffic will be detoured via Airport Road, Spanish River Boulevard, Military Trail and Butts Road. FHP will be on site to assist motorists. **Description:** This 2.75-mile project located in West Palm Beach and Lake Worth Beach began on August 10, 2022. Improvements include milling and resurfacing segments of I-95 in both directions, installing new signage, including an overhead Dynamic Message Sign on I-95 northbound just south of 10th Avenue North, upgrading existing lighting with LED luminaires and installing a new Road Weather Information System (RWIS). **Cost/Completion:** \$3.4 million/Fall 2023

# Traffic Impact:

 I-95 between Lake Worth Road and Forest Hill Boulevard may have two lanes closed in each direction nightly, 10 p.m. to 5:30 a.m., Sunday, March 12, through Thursday, March 16, to remove temporary median walls. # 3. SR 9/I-95 at SR 786/PGA Boulevard Southbound Entrance Ramps Project

**Description:** This 0.65-mile project in Palm Beach Gardens began on November 9, 2022. Improvements consist of reconfiguring the I-95 southbound entrance ramps at PGA Boulevard. The I-95 southbound entrance ramp from westbound PGA Boulevard to southbound I-95 will be converted from a merge lane to an additional, free-flowing lane. The I-95 southbound entrance ramp from eastbound PGA Boulevard to southbound I-95 will be reconfigured to become a merge lane. In addition, I-95 will be widened between PGA Boulevard and Burns Road, and lighting, drainage, signage and pavement markings will be upgraded.

## Cost/Completion: \$9,977,382/Spring 2024

## 4. George Bush Boulevard Improvements Project

**Description:** This 0.8-mile roadway improvements project, from NE 2<sup>nd</sup> Avenue to State Road A1A in the City of Delray Beach, began Monday, July 19, 2021. The City of Delray Beach, as Project Sponsor, requested that the Florida Department of Transportation (FDOT), District Four design and construct this project through application to the Palm Beach Transportation Planning Agency and City of Delray Beach Resolution 06-18. Work includes milling and resurfacing with minor widening, concrete sidewalk and driveway replacement, including curb and gutter improvements, signing and pavement marking upgrades, including bike lane and detectable warning surfaces, and drainage and utility improvements.

Cost/Completion: \$2 million. Completion is expected in summer 2023.

## **Traffic Impact:**

 One lane in each direction of George Bush Boulevard from just east of the George Bush Blvd ICW Drawbridge to SR A1A may be closed Monday through Friday, 7 a.m. to 6 p.m., for curb and gutter, sidewalk work, and lighting pull box installation. During this time, a flagging operation will direct eastbound and westbound traffic as needed. Emergency vehicles, local driveway, and pedestrian access will be provided at all times. ## 5. Homewood Boulevard Improvements Project

**Description:** This 0.8-mile roadway improvements project from Old Germantown Road to Lowson Boulevard in the City of Delray Beach began Friday, November 12, 2021. The City of Delray Beach, as Project Sponsor, requested that the Florida Department of Transportation (FDOT) District Four design and construct the Homewood Boulevard Improvements Project through application to the Palm Beach Transportation Planning Agency, Palm Beach County Resolution 2021-0169, and City of Delray Beach Resolution 06-18. Work includes milling and resurfacing the roadway with minor widening; concrete sidewalk and driveway replacement, including curb and gutter improvements; signing and pavement marking upgrades, including bike lane and detectable warning surfaces; installation of four (4) new signal mast arms at Linton Blvd. to meet current standards; and drainage and utility improvements.

Cost/Completion: \$2.5 million. Completion is expected in early 2023.

# 6. SR 802/Lake Worth Road Improvements Project

**Description:** This 1.90-mile project from Raulerson Drive to Palm Beach State College Entrance/Douglas Drive in the city of Lake Worth Beach began on Monday, November 14, 2022. Work includes constructing a new exclusive right turn lane from eastbound Lake Worth Road into the Mid-County Senior Center, installing new seven-foot bike lanes with upgraded safety features, milling and resurfacing Lake Worth Road in both directions, replacing underground Palm Beach County utilities throughout the project limits, improving sidewalk and driveways on both sides of Lake Worth Road, modifying medians to improve motorist safety, improving signalized intersections and pedestrian crossings, and installing new signage, pavement markings, and lighting.

Cost/Completion: \$14 million. Completion is expected in winter 2024.

- The outside eastbound lane on Lake Worth Road from Foss Road to Coconut Road is closed for turn lane construction.
- The inside east bound lane on Lake Worth Road from Davis Road to Congress Avenue is closed for force main construction.

# 7. US-1/SR-805 Lighting and Signalization Improvements Project

**Description:** This 0.400-mile project began on Thursday, August 11, 2022. Work includes installing new steel mast arms at the intersections of US-1/Lake Avenue and US-1/Lucerne Avenue, installing new light poles with LED Luminaires, replacing concrete sidewalk, driveways, and curb and gutter impacted by LED light pole installation, signing, and

pavement marking upgrades, including detectable warning surfaces, improving intersection street lighting and pedestrian signalization.

**Cost/Completion:** \$1 million. Completion is expected in Spring 2023.

# 8. Southern Boulevard (SR 80) Bridges Replacement Project

**Description:** This 0.76-mile project includes replacing the existing bascule (draw) bridge and tide relief bridge over the Intracoastal Waterway (ICWW) and Lake Worth Lagoon between the Town of Palm Beach and the City of West Palm Beach. The project limits are between Washington Road in West Palm Beach and State Road A1A/South Ocean Boulevard in Palm Beach. New decorative lighting, pedestrian features, traffic signals, signage and drainage are included.

**Cost/Completion:** \$97 million. Completion is anticipated in summer 2023.

## Traffic Impact:

- Flagler Drive from Southern Boulevard to Monroe Drive is closed through spring 2023 as it is reconstructed. Access will be maintained for local traffic only. Traffic will be detoured as follows:
  - Traffic going north on Flagler Drive should: Go west on Southern Boulevard to Washington Road; go north on Washington Road to Monroe Drive; go east on Monroe Drive to Flagler Drive.

• Traffic going south on Flagler Drive should: Go west on Monroe Drive to Washington Road; go south on Washington Road to Southern Boulevard; go east on Southern Boulevard to Flagler Drive.

# Marine Impact:

- The navigable waterway through the Southern Boulevard Bridge is restricted to halfchannel navigation. During half-channel closures, the horizontal clearance through the bridge is 40 feet.

## BRIGHTLINE:

Brightline will begin testing trains at high speeds up to 110 miles-per-hour in northern Palm Beach County as soon as Friday, February 17 and continuing through the month.

The high-speed testing in Palm Beach County will take place from Jupiter, Palm Beach Gardens, North Palm Beach, Lake Park, Riviera Beach to West Palm Beach and will occur daily between 7AM and 7PM. Flaggers will be present at railroad crossings when there is ACTIVE testing taking place in the area and there will be an increased law enforcement presence around railroad crossings.

The testing is in preparation for opening to Orlando in 2023 and will continue in phases along the 129-mile rail corridor between West Palm Beach and Cocoa.
