Drainage Work & Driveway Reconstruction on SR 607/Emerson Avenue Begins Monday, March 17, 2025

This notice is to inform you that drainage work will begin on **Monday, March 17, 2025**, within the Florida Department of Transportation (FDOT) right-of-way on SR 607/Emerson Avenue between Citrus Park Boulevard and 25th Street Southwest. This work along the project corridor will require driveway modifications and is expected to be completed in approximately four months, weather permitting. Mailboxes in conflict with the drainage work will be relocated to maintain mail service. Residential and business access will be maintained throughout construction.

During this period, private driveway access will be impacted, with closures from 10:00 a.m. to 2:00 p.m., Monday through Friday, weather permitting. Residents can park on side streets or arrange alternative access with the contractor. The work at each driveway is anticipated to be completed in one day. If work cannot be completed in one day, temporary access will be provided.
