In partnership with the Florida Park Service, St. Lucie County, and the St. Lucie Transportation Planning Organization, the Florida Department of Transportation (FDOT) is pleased to announce the construction of the newest segment of the Shared-Use Nonmotorized (SUN) Trail Network which will be located within the Savannas Preserve State Park. In advance of the construction, FDOT will be hosting both virtual and in-person public information meetings to discuss the project details. We invite you to learn more about this exciting project and the efforts to build a connected SUN Trail Network. The meetings will be held on Tuesday, July 18, 2023. Construction Cost: \$10.6 million

Construction Start: July 2023

Estimated Completion: Summer 2025

PROJECT IMPROVEMENTS

- This segment of the Shared-Use Nonmotorized (SUN) Trail Network will be located within the Savannas Preserve State Park. The SUN Trail project improvements consist of constructing approximately 6.8 miles of 10-foot-wide accessible multi-use trail with boardwalk sections.

TRAFFIC IMPACTS

- Single-lane closures are permitted on Walton Road Monday through Sunday as follows:
 - Daytime, Monday through Sunday from 9:00 a.m. to 3:00 p.m.
 - Nighttime, Sunday through Thursday from 9:00 p.m. to 5:30 a.m.
 - Nighttime, Friday and Saturday from 11:00 p.m. to 7:00 a.m.


