PROPOSED IMPROVEMENTS

- Repave and restripe the existing roadway within the project limits
- Sidewalk replacement, removal of abandoned driveways, and providing sidewalk connectivity and continuity
- Pedestrian signalization and lighting improvements at signalized intersections
- Miscellaneous drainage improvements to comply with Americans with Disabilities Act (ADA) standards and minor ponding concerns
- Upgrading signing and pavement markings

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the effects of construction on the community
- No construction will be allowed during weekends
- Access to properties adjacent to the corridor will be maintained throughout construction
