


# **Project Overview**

- New north–south connection between State Road 60 and County Road 510
- Sebastian River Improvement District (SRID)
  - Lateral Canal "C"
  - SRID Sub Lateral Canal













#### South Project Proposed Improvements




### South Project Proposed Improvements






#### North Project Proposed Improvements

- Treatment of runoff discharge for grease, oil, and sediments



# **Traffic Control Plan**

- Two-way traffic will be maintained on the existing 82nd Avenue
- Work will be done in phases to reduce the effects of construction on the community
- Existing driveway access will be maintained throughout construction





# **Right of Way**

- Right of Way purchases required to accommodate Complete Streets features
  - South Project 10-foot Shared Use Path
  - North Project 5-foot Sidewalk








### Final Design

North Project – Complete mid-2023 South Project – Complete late-2025



### **Construction**

Currently unfunded until further notice North Project – 1.5 years to construct South Project – 2.5 years to construct



### **Estimated Cost**

\$10.6 million - North Project\$29.3 million - South Project
