The Florida Department of Transportation (FDOT), District Four, will host a Virtual Public Meeting and In-person Construction Open House regarding the upcoming SR 9/I-95 northbound and southbound off-ramps at Midway Road improvements in the City of Port St. Lucie. Construction Cost: \$2.6 million **Construction Start:** November 2022 **Estimated Completion:** Summer 2023

PROJECT IMPROVEMENTS

- Adding a second left-turn lane to both the SR 9/I-95 northbound and southbound off-ramps at Midway Road (Exit 126)
- Widening and repaving the existing SR 9/I-95 off-ramps
- Upgrading traffic signals with new mast arm poles and improving signalization timing and alignment
- Implementing Wrong Way Driving Countermeasure Systems
- Upgrading signing and pavement markings

TRAFFIC IMPACTS

- Lane closures are permitted Monday through Sunday as follows:
 - Nighttime, Monday through Friday from 8:00 p.m. to 6:30 a.m.
 - Daytime, Saturday and Sunday from 6:30 a.m. to 8:00 p.m.
- Business and residential access will be maintained at all times


